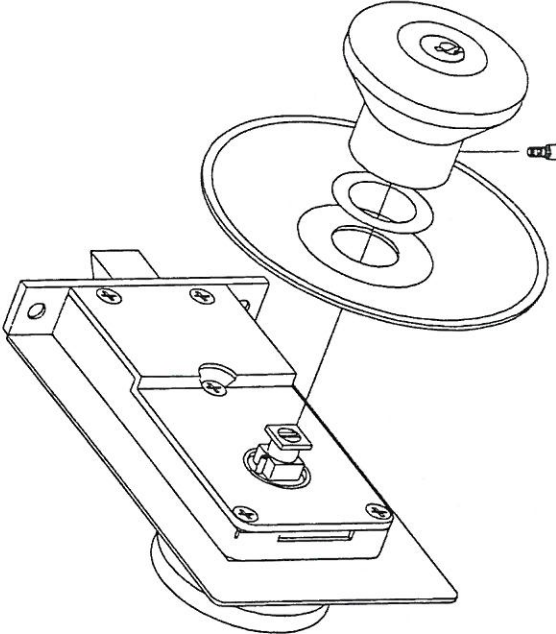

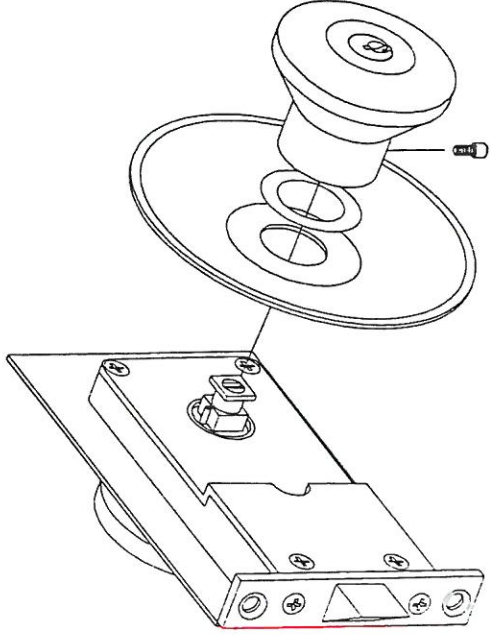

5 AND 7 SHOWN IN EXPLODED POSITION (R.H. HINGE APPLICATION - GENERAL SIDE)

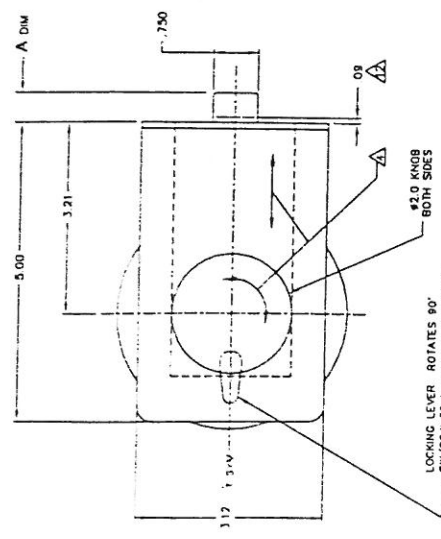

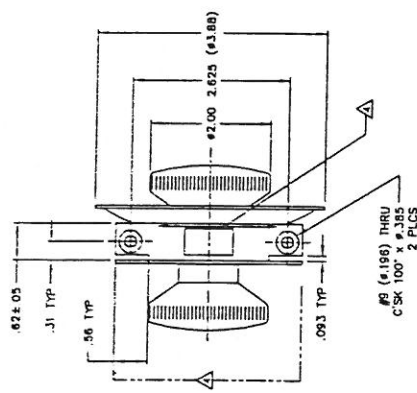
